(ii) A time bound commitment for compliance of proper shade and concrete flooring for the pole swaging and welding area may be obtained from M/s Swastik Pipe Ltd. through the contractor M/s Tata Projects.

Please note that the above equipment, manufactured and supplied by M/s Swastik Pipes Ltd, Mathura works shall meet the requirements of POWERGRID's Technical Specification / Approved Drawing/ Data Sheets including type testing, as per the specification. If, at any point of time, any non-conformity is noticed in this regard, we reserve the right to withdraw this approval with immediate effect.
